Currently the Brownsfield administrator is writing a grant for more Brownsfield money for cleanup. The last project that the County paid for with Brownsfield money was the cleanup of asbestos at the Irle School.

Ms. Amundson suggested that with future County projects that the Commissioners are working on that they ask themselves "what can GNDC help with."

Ms. Amundson stated that they would keep their eyes open for infrastructure funding for the levy.

Conversation continued concerning a building across from the Coke plant that the County owns on Burlington Northern property. Ms. Amundson asked if there had been an assessment done on the property, and if there was asbestos. If so, it could be a possible GNDC project.

The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Bruce H. Peterson, members Paul Tweten and John Fahlgren, and Recording Secretary Ruth Dowell present.

Leanne Fontaine, Administrative Assistant for the Extension Agency, came in concerning the storage of various records in Valley County.

Vernon Buerkle, Valley County Sheriff, stopped by to advise that the Department of Homeland Security has a grant available that he would like to apply for, the application is due by March 3rd. Sheriff Buerkle would like a grant writer to take care of grants for Valley County.

Commissioner Peterson states that he has mixed feelings about having a grant writer for Valley County. His contention is that if we as a County look to use every grant available then we should not complain about government debt.

Sheriff Buerkle stated that if we are able to apply for grants it will free up other money for the betterment of Valley County.

Several names were brought up as potential grant writers for Valley County. Sheriff Buerkle will check into the grant further as well as searching for potential grant writers.

Roubie Younkin, Extension Agent, came in to discuss various subjects.

Larry Brence, Montana State University Eastern Region Department Head, stopped by to discuss upcoming budget cuts as well as the Extension personnel that are working with Valley County.

Rick Seiler, Valley County DES Coordinator and Todd Young, Valley County Road Supervisor, came into the office for a teleconference concerning the Pre-disaster Mitigation Plan with Mike Kemp, consultant from Integrated Solutions Consulting which is headquartered in Minneapolis, Minnesota. Mr. Kemp, the son of Ron Kemp of Glasgow, is faculty chair at Capella University in addition to his consulting.

Commissioner Fahlgren wondered what mandates Valley County to have a Pre-disaster Mitigation Plan produced. Mr. Kemp said that it is federal law and a successful state and Federal Emergency Management Agency FEMA approved plan qualifies Valley County for funding projects from a variety of sources. Approval of this plan by the Commissioners is not an obligation for the county to take any action.

Commissioner Fahlgren wondered if a potential problem with pipeline protestors would qualify for grant funds, despite not being listed in the Pre-disaster Mitigation Plan. Mr. Kemp said there is a process available, on page 163 that will allow changes to be made and still be qualified for grant funds. He said to keep in mind that both the State and FEMA have approved the 2016 Plan so they should not be able to prevent applying for funds for such an instance. There is a North Dakota county trying to do this very thing right now and he could put us in contact with them if the county so desired. In other words this is a living document.

Mr. Seiler asked why Marten Coulee showed so high on the priority list. Mr. Kemp said that this was probably suggested by a private citizen and that is part of the process, to get input from the public. In addition keep in mind that the prioritization list is based on cost benefit analysis and does not mean that a county has to follow the list precisely. This list is a requirement from FEMA and they are trying to produce a good reference source for counties.

Mr. Kemp said that if the county decided to do a project from the list they have to start from scratch and do a new cost analysis and other requirements in order to be eligible for funds. This 2016 Plan puts Valley County on the approved list to get started.

Commissioner Peterson asked how such things as projected timeline were figured, i.e. who determines if the project is short term, or long term. Mr. Kemp said that he looks at each project and assigns a number and then sends a completed list to local coordinators who present the ratings in public meetings and the numbers can be changed with their input.

Mr. Kemp gave a strong recommendation that Valley County DES Coordinator get a good working relationship with Nadine Wadsworth from the State DES office as she can be a key in helping to fund listed projects from the 2016 Plan.

Commissioner Peterson asked if there were cost numbers listed anyplace. Mr. Kemp said that they do get some numbers as the Plan is prepared but they never put them in book because when a county decides to pursue a project it has to be started from scratch.

Mr. Kemp was asked to make comment on what Valley County should do starting today. He said that Valley needed to approve the plan, then get good relations going with state, and then have a sit down with local folks to ask what project(s) should be seriously considered.

There was discussion on what weather data was available, the value of that data in present form, and what could have been done with a more lucrative contract. The 2016 Plan follows regulation/law guidelines and format and all consultants produce very similar content information.

A motion was made by Commissioner Fahlgren, seconded by Commissioner Tweten and passed unanimously authorizing the Chairman to sign Resolution No. 10-2017, Valley County Mitigation Plan an Application.

The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Bruce H. Peterson, members Paul Tweten and John Fahlgren, and Recording Secretary Ruth Dowell present.

A motion was made by Commissioner Tweten on October 28, 2016 authorizing Acting Chairman Peterson to execute an Application and Permit to Use Right-of-Way No. 700, between Valley County and Nemont., for the construction of an underground utility line boring near Park Grove in the following location:

Starting at Lot 1 across to lot 25A for Kris Simensen new service. The motion was seconded by Chairman Peterson and it unanimously passed. Recording was delayed awaiting payment from Nemont. The said Document, No 159906, was recorded in the office of the Clerk and Recorder on February 10, 2017.

Dylan Jensen, Valley County Attorney, was in to discuss a potential bill to the County to finish up the airport project. There has been concern that an approximate \$125,000 in change orders, grass planting and extra gravel, were not approved by Valley County. The County's match share of that amount is 10%. Attorney Jensen has studied the contracts with DOWL Engineering, Century Paving, and the Federal Aviation Administration (FAA) and has also called FAA and the State of Montana Aeronautical Office, Tim Conway, about this matter. He shared his preliminary thoughts with the commissioners.

Attorney Jensen said that FAA has a policy with the construction companies that allows them leeway on costs of up to 25% without doing a change order. But, that is between the FAA and the company and Attorney Jensen, and Mr. Conway, believe that that relationship has no effect on any contracts signed between Valley County and DOWL and Century. He feels our contracts are very clear that the two companies have to get permission from Valley County to do any change orders. It was mentioned that FAA evidently has already cut check for extra costs, but Attorney Jensen believes that does not obligate Valley County to pay 10% match on what FAA has paid.

The tentative plan is for Valley County to not pay the 10% match at this time, but when the DOWL representative comes to the airport commission meeting that a meeting be scheduled with the Commissioners, DOWL, airport commission representative, and Attorney Jensen to talk about this matter. Commissioner Peterson reiterated that his concerns were that extra gravel was hauled in because of rainy summer should have been part of original bid if the engineering were done right, and that the extra grass area should also have been part of original bid. With that in mind there should not have been need to do a change order.

Todd Young, Valley County Road Supervisor, came in to discuss various road projects in Valley County.

February 17, 2017

Commissioner Tweten and Commissioner Fahlgren were in the office today.

Mike Bain, Computer Tech, came in to install a program on the office computer.

Stone Tihista, Valley County Weed Department, came in to discuss the need for a computer with GIS mapping for the Weed Department.

Commissioner Peterson was in the office this afternoon.

February 21, 2017

The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Bruce H. Peterson, members Paul Tweten and John Fahlgren, and Recording Secretary Ruth Dowell present.

David Pippin, Valley County Museum came in concerning the fire alarm system at the Pioneer Museum. Mr. Pippin is meeting with API this afternoon to discuss options for the system.

Connie Boreson, Valley County Health Department Supervisor, and Lynn Miller, Valley County Health Department, came in to discuss applying for a grant for Ms. Miller.

Connie Boreson wanted to apply for a grant for Lynn Miller to get training for Public Health Accreditation. Previously, Ms. Boreson was allowed to pursue further education and created a Workforce Development Plan. Ms. Boreson states that former Commissioner, David Reinhardt signed off on the plan that states that Valley County will support education related to workforce development. The guideline was presented to the Commissioners. According to Ms. Boreson, applying for the grant seems like an opportunity to follow the guidelines established by the workforce development plan in assisting with schooling funding. Ms. Miller filled out an application for the program and is now in the process of applying to a school.

The majority of the funding for the schooling would come from the grant in question, with the remaining \$1,800 coming from the HIV/AIDS grant. Ms. Boreson feels that a precedence has been sent to close the HIV/AIDS grant by using the money to go toward education.

Lynn Miller stated that the schooling she is pursuing is available online if she is chosen to participate in the program. It is four semesters of training with one class per semester. This would give Ms. Miller a certificate in Public Health that would assist her in her goal of a Master's Degree.

Ms. Boreson stated that when she took her training, there were not any credits attached to her training. The difference is that Ms. Miller will receive credits for the training that she is taking.

Ms. Miller stated that it can take years for the Health Department to receive accreditation, but this certificate is working toward that goal.

Ms. Boreson states that this is the foundation of the accreditation process.

Ms. Miller stated that accreditation is her pathway to learn the language of the Health Department.

Commissioner Fahlgren asked if it is difficult to take the classes.

Ms. Boreson stated that the University of Montana has to accept Ms. Miller as a student before she will be able to take the classes.

Ms. Miller stated she would be happy to send any of her paperwork to the Commissioners to review.

Commissioner Peterson stated that we are too small and we will never get accreditation as per what Ms. Boreson and Ms. Miller have been saying.

Neither Ms. Boreson nor Ms. Miller are willing to say never.

Ms. Boreson will send information on accreditation and the grant program.

Commissioner Peterson stated that he feels that Ms. Boreson is proof that you do not need a nursing degree to be an administrator. He feels that we need nurses to do nursing.

Ms. Miller states that the classes will teach Health Department related materials toward administration. She states that she has the time to do it, is excited about it, and is willing to do it.

Ms. Boreson states that a good administrator plans for their departure. Ms. Boreson also mentioned that what we are planning for today is the betterment of the Valley County Health Department.

Ms. Miller stated that she is not saying that she plans on taking the position once Ms. Boreson leaves, but Valley County benefits from the education she will have from the classes.

Commissioner Fahlgren asked what Ms. Miller will do when the program ends.

Ms. Miller states that the certificate is one half of a Master's Degree, and it appears that they strongly encourage the completion of a Master's Degree.

Commissioner Tweten states that to simplify it, Valley County has an HIV/AIDS grant that could pay the County's portion of the grant.

Commissioner Peterson states that he sees the value, but also thinks there are other programs that could better use the grant money. The recent survey has identified wellness, drug abuse, and mental health as areas of most concern.

Ms. Boreson contacted the auditors to find out if she can use the HIV/AIDS grant for education and was told that she could.

Ms. Miller stated that the money spent for her education will pay off over the next ten years and is wondering if that money would be as well spent on Mental Health.

Commissioner Peterson stated that he is certain that there would be a benefit to the community over the next ten years if the money is put into Mental Health. Commissioner Peterson asked if we are willing to do the same type of training in other departments.

Commissioner Peterson stated that the Commissioners are going to Frazer and Nashua this evening for Community Meetings and he would like to know what he can tell them concerning Oral Health. He would like to see the Health Department consider going to Frazer to work on oral health. In the Oral Health Grant, region one, tribes, and underserved are mentioned. He is wondering if Valley County could plan one day to go to Frazer and Nashua and do oral health.

Ms. Boreson stated that they put fluoride varnish on the children's teeth to aid in prevention of tooth decay.

Ms. Miller stated it is something they would have to plan for and check into.

Ms. Boreson and Ms. Miller left the office.

Patrick McGuiness from St. Marie stopped in to let the Commissioner's know that the stop sign on Cedar Street in St. Marie has been knocked down. Commissioner Tweten forwarded the message to Todd Young, Valley County Road Supervisor.

Vernon Buerkle, Valley County Sheriff, came in to discuss the Custer County Pipeline Unrest meeting that he attended in Miles City last week. Keystone is talking to Fort Peck and will continue to have public meetings. The pipeline will be done in four sections with four man camps. It was determined that Sheriff Buerkle should continue attending the Keystone pipeline meetings.

Also discussed with Sheriff Buerkle was the use of the refrigerated room in the Detention Center. Sheriff Buerkle says it appears that there has been some advantage taken in the use of the refrigerated room. He will monitor the situation to determine if anything different needs to be done.

Briefly touched upon was the possibility of combining the Valley County websites and paying a company to maintain the website for a more user friendly experience. Sherri Turner and Janet Garrison will stop in tomorrow to discuss future plans.

Lynne Nyquist, Valley County Clerk and Recorder, came in to discuss precinct boundaries for voting.

Dan Carney, Fire Marshall, stopped by to pick up paperwork and discuss the fire engines that are on loan to the Fire Department.

Commissioner Peterson and Commissioner Tweten attended Community Meetings in Frazer and Nashua last night.

Commissioner Tweten advised that the main thing that he took away from the Nashua Community Meeting is that they would like to have the County Health Nurse come to the Nashua School.

Sherri Turner, Sheriff's Administrative Assistant and Janet Garrison, Valley County Dispatch, came in for their meeting to discuss outsourcing Valley County's web design to a company that could make it more user friendly. The set up would cost approximately \$3,000 with an annual maintenance fee of \$1,200.00. The County would no longer have to pay Nemont for the maintenance of two websites. Ms. Garrison suggested that updating could be done by each department.

Commissioner Peterson asked if Valley County has the ability to update our website without bringing in another company.

Ms. Garrison stated that she is updating the website constantly, having to keep a hard drive with her 24/7 to make sure the site is updated.

Ms. Turner stated that we could have current information on the website, such as polling districts.

Ms. Garrison stated that our website is old and hard to navigate.

Ms. Turner stated that if you look at some other websites you will see the ease with which they operate.

Commissioner Peterson stated that we can currently link to other sites.

Ms. Turner stated that it would be easier and quicker to update the site under a different administrator.

Ms. Garrison mentioned that we would incorporate both websites that we now have into one website.

Commissioner Fahlgren asked if they could be shown the difference between the current website and a new website.

Ms. Turner stated that our website is sixteen years old and there has been a lot of update in software since that time.

Ms. Garrison provided examples of various Montana county sites that are currently outsourcing their web design.

Commissioner Peterson wanted to verify that the County will still have to pay someone to update the site, so there will be no savings on salary because we will still need someone to head the gathering of information. Commissioner Peterson also asked if there is anyone locally that can do the same job.

Ms. Garrison stated that this is a government website builder and it is a good deal.

Commissioner Peterson asked if they have shopped around.

Ms. Turner stated that this is an established company that will not be gone in two years. Ms. Turner mentioned that she searches a lot of sites for sheriff information and this company seems to have very user friendly sites.

Ms. Garrison's biggest concern is that we need a better website, one that can be easily maintained, and one that she doesn't have to worry about.

Commissioner Fahlgren states that the website should be able to encourage economic development by encouraging people to move here.

Ms. Garrison stated that the steps taken to post to a new website are greatly reduced through this new website. There will be four confidential logins to update the site. If an agreement is made by the end of the month, it would cost only \$3,000 with \$1,200 per year maintenance on a five year contract, including automatic updates and virus protection.

Commissioner Peterson asked if they have an example of a contract.

Ms. Garrison does not know what we are paying Nemont for the two websites the County currently has, but we would drop the expense of an extra domain.

Commissioner Peterson asked what other places are outsourcing their websites to this company. He was told Glendive, Livingston, and the City of Hamilton.

Commissioner Peterson stated that we would save \$500.00 for migration and \$219.00 in set up fees by getting the order in by the end of the month.

Ms. Garrison will check into how much the County is currently paying for both of the websites.

The Commissioners will take the decision under advisement.
