Glen Meier, Valley County Sheriff, stopped in and informed the Board that he needs a Resolution that authorizes over-time pay for DUI Task Force hours worked. This will be handled in the same manner as the Stone Garden and STEP hours are paid.

A memo was distributed to the Department Heads to give to their employees advertising in-house for a custodial & building maintenance Supervisor.

The Commissioners left the office to tour the Northeast Montana Fair activities over the noon hour.

Colleen Pankratz, Valley County Transit Supervisor, visited with the Commissioners about a variety of issues. She voiced her frustration with the computer program that dispatches her buses and said she is seriously considering dropping that computer program.

The Commissioners told Mrs. Pankratz that they would back her decision regarding the computer program and they realize the program has not worked well for her since the beginning.

The group discussed the Valley View contract and costs to use Valley County Transit versus Valley View owning their own bus.


Mrs. Pankratz left the office.

The Department of Revenue submitted the 2015 Certified Taxable Valuation Information for Valley County.



Norman Girard visited with the Commissioners about his projected taxes for the next year.



AUGUST 5, 2015

The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Dave Reinhardt, members Bruce H. Peterson and Paul Tweten and Recording Secretary Joanne Strommen present.

Dave Pippin informed Commissioner Tweten that he will be submitting a letter in support of the Bentonite Plant in hopes that the Valley County Commissioners will consider also sending a letter to BLM regarding the BLM's proposed Resource Management Plan (RMP).

Glen Meier, Valley County Sheriff, visited with the Commissioners about a variety of things.

Sheriff Meier left the office.

The Commissioners discussed the \$600 invoice from Two Rivers for membership dues and it was agreed that the Commissioners will continue to be a member of that organization.

Stan Ozark, KLTZ/Mix 93, joined the meeting.

Chairman Reinhardt began Discussion and Decision at 10:30 a.m.

Chairman Reinhardt asked for any additions and/or deletions to the agenda and none were given and no public comment was submitted when asked.

The first item on the agenda for action was Employment/Termination Notices.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Rayshell McDonald as a permanent, part-time Secretary, for the Health Department, increasing her pay to \$12.00 per hour, because she has completed her probationary period, effective July 12, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Paul Siefert as a permanent, full-time Blade Operator and Operator for the Bridge Crew for the Road Department, beginning August 3, 2015, at \$17.27 per hour. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Brian Austin as a permanent, full-time Supervisor for the Refuse District, increasing his pay by \$.46 per hour, effective July 1, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for August Aho as a permanent, full-time Operator for the Refuse District, increasing his pay by \$.53 per hour, effective July 1, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Mark Arneson as a permanent, full-time Operator for the Refuse District, increasing his pay by \$.47 per hour, effective July 1, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Jim Wilson as a permanent, part-time Operator for the Refuse District, increasing his pay by \$.35 per hour, effective July 1, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Kari Lee Knierim as a permanent, part-time Secretary for the Refuse District, increasing her pay by \$.38 per hour, effective July 1, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Termination for Terry Young as a Driver for the Transit, effective July 1, 2015. The motion was seconded by Commissioner Tweten and passed unanimously.

The next item on the agenda for consideration was Great West Engineering's Contract for the replacement of the Milk River Road Bridge.

Commissioner Peterson said that he was not finished with FY 2015-16 budgets yet. Lynne Nyquist, Valley County Clerk and Recorder, is out of the office this week for some training in Billings, and he needed some more information from Mrs. Nyquist to complete the budgets. So, he is not ready yet to make a commitment for the bridge project. He said he is concerned that the Commissioners will have to decide what they are going to cut to fund this project. He understood that if they chose to move forward with this project, then they will have to budget the entire \$440,000 this year.

Chairman Reinhardt said the contract from Great West for the design and supervision of the project has an estimated maximum cost of \$183,226 and that is part of the \$440,000 amount that has to be budgeted. Discussion followed.

Commissioner Peterson said that he has looked at budgeting this project in PILT, Local Option and the Oil Gas Tax funds. He said his projection is, with supplementing the budget and this project, it will take PILT and the Local Option budgets to \$0.00, and that is his concern. He said he could not support this project at this time. If the Commissioners move forward with this, then they will have to be very careful not to take on anything else. He said he had hoped they would have an in depth conversation regarding the funding of these projects and decide what they need to do. Various projects were discussed.

Chairman Reinhardt said that he did not believe there had to be any cuts made. There was some question as to whether the money from the grant will be reimbursed as the expenses were paid or if the grant money was paid once the project is completed. After looking at the grant application, it was determined that the expenses are reimbursed as they are paid, not in one lump sum when the project is completed.

Commissioner Tweten said there is still \$189,000 in the Disaster 2 mill account, and there is money yet to come from FEMA to reimburse for some projects that were done. He believed some of that could possibly be used for funding the bridge replacement. Discussion followed.

A motion was made by Commissioner Tweten to sign the 2015 TSEP Bridge Design, Construction Administration and observation, and grant administration services with Great West Engineering at a cost of \$183,226. The motion was seconded by Chairman Reinhardt.

Commissioner Peterson said that he would have to vote against this because he does not see how this will fit into their budgets, and because the Commissioners have not had a good discussion regarding this project.

Commissioner Tweten said he would support this motion because he believes there is still a half of a million dollars coming in for FEMA projects that have not been reimbursed yet, and could go towards this project.

Chairman Reinhardt called for the vote and *the motion carried with two ayes and one nay from Commissioner Peterson.*

The purchase of a Pickup for the Weed District was the next item on the agenda.

Chairman Reinhardt said there were two quotes submitted to Stone Tihista, Valley County Weed/Mosquito Coordinator, from the local dealerships, Newton Motors at \$36,510, and Hi-Line Ford at \$41,400.

A motion was made by Commissioner Peterson to accept the quote from Newton Motors to purchase a 2015, 3500 HD Chevrolet pickup, at a cost of \$36,510. The motion was seconded by Commissioner Tweten and it carried unanimously.

Next on the agenda was Resolution No. 20-2015 - Authorizing Overtime Hours Paid at 1 1/2 times for the DUI Task Force.

A motion was made by Commissioner Tweten to execute the following Resolution, seconded by Commissioner Peterson and passed unanimously:

RESOLUTION NO. 20-2015

RESOLUTION AUTHORIZING THE OVERTIME HOURS PAID THROUGH THE OPERATION OF THE DUI TASK FORCE

WHEREAS, the Sheriff's Office has received funding through the **Montana Department of Transportation (DOT) DUI Task Force**; and

WHEREAS, the DOT supports enhanced cooperation and coordination among local, tribal, territorial, State, and Federal law enforcement agencies in a joint mission to secure the United States' borders along routes of ingress from international borders to include travel corridors in States bordering Mexico and Canada, as well as States and territories with international water borders; and

WHEREAS, DOT DUI Task Force funds will allow the Valley County Sheriff's Office to conduct special enforcement for impaired driving mobilizations, occupant protection mobilizations, underage drinking and prevention; and

NOW, THEREFORE, BE IT RESOLVED that, effective July 1, 2015, through June 30, 2016, the Board of County Commissioners hereby agree to compensate Deputies in conjunction with the availability of DOT DUI Task Force funds to pay:

"All hours that the Sheriff assigns as DUI Task Force hours shall be paid at the rate of time and one-half (1½) of the Deputies regular rate of pay. There shall be no pyramiding of time."





The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Dave Reinhardt, members Bruce H. Peterson and Paul Tweten and Recording Secretary Joanne Strommen present.

Mike Bryan stopped in and asked about the maintenance supervisor position that is currently being advertised in house. The Commissioners told him that the opening is being advertised in house first and was not open to the public as of yet. He was told that if the position is not filled internally, than Mr. Bryan would be informed of the advertisement when it is publically posted.

Mr. Bryan left the office.

Bob Steele, Maintenance Supervisor, updated the Commissioners on the maintenance activities.

Commissioner Peterson left the office for the day.

Adam Mummy, Adam's Asphalt, stopped in and visited with the Commissioners about the Sunny Hills Drive. He said he could fix the patches for \$30,000 and put a 3" overlay on the road for \$80,000. He described the project and said the overlay is really what needs to be done.

AUGUST 11, 2015

The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Dave Reinhardt, members Bruce H. Peterson and Paul Tweten and Recording Secretary Joanne Strommen present.

Chris Knodel, Long Run Fire Chief, stopped in and the Commissioners gave Chief Knodel the two bids that were submitted for the Long Run equipment that was advertised in the paper. Discussion followed.

Chief Knodel said Long Run would submit a request to the Commissioners to sell the equipment to the highest bidders and he left the office.

Chief Knodel left the office.

Chairman Reinhardt and Commissioner Tweten left the office to visit with Nick Murnion, Valley County Attorney, about the proposed BLM HiLine Resource Management Plan (RMP) and the problems it will cause for Valley County if approved.

Mr. Murnion agreed that a letter should be sent documenting the Commissioners' concerns.

The Commissioners left the office to participate in a job interview for the Valley County Courthouse maintenance supervisor position.

Commissioner Peterson left the office for the day at noon.

Darrel Bergtoll and Curtis Cadwell joined the meeting for their appointment.

Mr. Bertoll said he was there because he wanted to close the access to a road that goes through the Black Ranch corals on his private property. He said that hunters access this road to get to some block management hunting ground. However, he didn't want to get into a conflict with BLM or the FWP, but this is not a Valley County Road and is private access.

Chairman Reinhardt verified that it is not a County road and that Mr. Bergtoll should be able to close it. Chairman Reinhardt suggested that maybe Mr. Bergtoll should send a letter to FWP telling them of his intentions to close that access to the public. After some discussion it was agreed that FWP would probably fight the closure.

Mr. Bergtoll said that several years ago the BLM installed some cattleguards on some of his private land and they did not contact or get permission from Mr. Bergtoll before, or after, they were installed. Discussion followed.

Mr. Bergtoll said he would not put a lock on the gate closing the access, because people would just cut down the fence if they were expecting to get through that gate late at night. He thought he would just put in a gate and post it as no trespassing.

Mr. Bergtoll said several years ago he was in and asked about closing the County road that ends at the old Jackson house. The road dead ends at that old house and does not provide access for anyone else but him.

Mr. Bergtoll was given the documentation that documents the process one takes to submit a request to the Valley County Commissioners to close a road.

After some discussion on a variety of issues, Mr. Bergtoll and Mr. Cadwell left the office.

Dave Pippin visited with the Commissioners about the HiLine Resource Management Plan (RMP) that the BLM is proposing and a letter that the Valley County Commissioners will be submitting.

The letter from the Commissioners had five issues of contention:

1. Valley County was not allowed any direct coordination in respect to the Valley County Resource Use Plan, a County Land Plan Document which covers County policy and many, if not all topics covered in the RMP.
2. Valley County was not consulted on the No Surface Occupancy (NSO) listing of LU Lands. No direct coordination with Valley County result in the forfeit and loss of the royalty revenue for these mineral rights which were provided in the original sale of these properties to the United States Government under the Bank-Head Jones Act. NSO stops Valley County from ever collecting any royalty revenue and constitutes a taking without compensation. It is well documented that royalty rights were a part of the original sale of land by Valley County to the U.S. government in 1939. This RMP also denies the rights and privilege of roadways and utility right-of-ways also afforded by the Bank-Head Jones Act.
3. This RMP fails to accurately address the development of bentonite in Valley County, even though the BLM had full knowledge of these leases and mining permits located in South Valley County. This new industry would have brought jobs and significant County tax revenues to Valley County, estimated to be in the hundreds of thousands of dollars range, has been stalled because the BLM is waiting for the implementation of this RMP which will severely restrict the economic feasibility of their business plan.
4. Data quality assurances were not followed with many items misrepresented, or totally ignored or left out of the document. Example: Total mineable bentonite reserves in Phillips and Valley County were not reported with a factual number, and in an unimaginable degree of error. The Bentonite reserve and or values stated in the RMP are less than what Valley County has in Mineable reserves on LU Lands. The royalty and severance tax revenues could well be in \$20,000,000 in value if developed.
5. We protest any action designed to close, or limit use on existing Valley County Roads or public access roads.

Letters will be sent to the Havre and Washington D. C. BLM Offices and Governor Steve Bullock.

Chairman Reinhardt left the office.

Mr. Pippin left the office.

Commissioner Tweten took the BLM letter to Mr. Murnion to critique and Mr. Murnion was satisfied with the content.

Commissioner Tweten said he would be attending the Valley County PDM/DBG Community Meeting this evening.

The meeting was adjourned at 4:00 p.m.

AUGUST 12, 2015

The Board of County Commissioners met in regular session in the office of the Commissioners with Chairman Dave Reinhardt, members Bruce H. Peterson and Paul Tweten and Recording Secretary Joanne Strommen present.

The Commissioners received an email from Chris Knodel, Long Run Fire Chief, requesting that the Commissioners accept the bid of \$1,287.50 from Dan Carney for the 1990 K2500 pickup and bid of \$2,750 from Fossum Ready Mix for the 1980 International Model F4370 - semi tractor/trailer with a 3,000 gallon water tank.

The Commissioners left the office from 9:00 to 9:30 a.m. to attend the Employee meeting.

Jenny Reinhardt, Valley County Airport Commission Secretary submitted Task Order No. 1 for the Airport's Fuel System Project and updated the Commissioners on the activities for the project.

Dowl Engineering told the Airport Commission that the projected plan was the cement will be poured in October and the fuel tanks should be installed in December.

A motion was made by Commissioner Tweten directing the Chairman to sign Task Order No. 1 that describes the engineering services at a cost of \$32,150, to install the new airport fuel system. The motion was seconded by Commissioner Peterson and it carried unanimously.

Mrs. Reinhardt left the office.

The letter created yesterday responding to the BLM's HiLine RPM was signed and mailed out today with copies going to the Washington D.C. and Havre BLM Offices and Governor Bullock's Office.

Dan Forbes, TransCanada Keystone Pipeline LP, (Keystone) joined the meeting.

Mr. Forbes said there is no new information regarding the permitting. He is the only person left in Montana working for Keystone. They have let everybody else go until something is decided on the permit applications at the federal level.

There was some discussion on some possibilities of gravel supplies because there will be a large supply of gravel needed for the two Man Camps and for road maintenance.

Commissioner Peterson asked if Keystone would consider giving the gravel that is temporarily put down on the Man Camp grounds to Valley County, once the Camps are removed. Mr. Forbes said he would inform Keystone that Valley County wants this gravel be given to the County to be used on Valley County Roads. Discussion followed.

Mr. Forbes left the office.

Chairman Reinhardt began Discussion and Decision at 10:30 a.m.

Chairman Reinhardt asked for any additions and/or deletions to the agenda and said that there are two additional Agriculture Exception Surveys that need to be signed, so they will consider those with the other survey they have on the agenda.

There was no public comment submitted and no Employment/Termination Notices submitted for action.

The Stan-Fuhr Subdivision Plat and the additional Agriculture Exemption Plats were the next thing on the agenda.

A motion was made by Commissioner Peterson authorizing the Chairman to execute Subdivision Plat No. 341B for the Karla M. Zerbe Living Trust to describe a tract of land with an Agriculture Exemption, described as;

The motion was seconded by Commissioner Tweten and the motion carried unanimously. The said Document, No. 156717, was filed in the office of the Clerk and Recorder on August 5, 2015.

A motion was made by Commissioner Peterson authorizing the Chairman to execute Certificate of Survey No. 428 for the Carroll Trading Company, LLC, to describe two parcels to be traded, described as;

SW $\frac{1}{4}$, Section 15, Township 30N, Range 37E, Montana Principal Meridian, Valley County, Montana;

The motion was seconded by Commissioner Tweten and the motion carried unanimously. The said Document, No. 156495, was filed in the office of the Clerk and Recorder on August 13, 2015.

A motion was made by Commissioner Peterson authorizing the Chairman to execute Certificate of Survey No. 427 for the Carroll Family Limited Partnership to retrace and/or re-monument a parcel with an Agriculture Exemption, described as;

The motion was seconded by Commissioner Tweten and the motion carried unanimously. The said Document, No. 156493, was filed in the office of the Clerk and Recorder on August 12, 2015.

The next item on the agenda was the Right-of-Way Permit Application from Nemont Telephone Coop.

A motion was made by Commissioner Tweten authorizing the Chairman to execute an Application and Permit to Use Right-of-Way No. 651, between Valley County and Nemont Telephone, for the construction of an underground utility line, boring under Community Road, crossing Sections 10 to 9, Township 27 North, Range 41 East. The motion was seconded by Commissioner Peterson and it passed unanimously. The said Document, No. 156505, was filed in the office of the Clerk and Recorder on August 14, 2015.

Next on the agenda was to appoint a Fair Commission Board member.

Chairman Reinhardt said that the Commissioners have received two letters from individuals stating their interest to be on the Fair Commission Board, Debbie Heitman and Doctor Kevin A. Ross.

A motion was made by Commissioner Tweten to appoint Doctor Kevin A. Ross to the Valley County Fair Commission Board, filling the vacated seat of Gene Hartsock, beginning immediately and ending December 31, 2017. Once this term is completed, the position will be reappointed as a three-year term. The motion was seconded by Commissioner Peterson and unanimously carried.

Resolution No. 21-2015, Update to the Valley County Resource Use Plan, was next on the agenda.

Commissioner Tweten said that René Clampitt, Planner/911/GIS Supervisor, was going to check and see if this plan must be approved by the Valley County Planning Board.

Commissioner Peterson said he would suggest it be reviewed by the Valley County Planning Board, this is a significant plan like the Growth Policy.

The Commissioners are going to give this to Mrs. Clampitt to have the Planning Board review it.

No action will be taken at this time.

Commissioner Tweten left the office for the day.

Commissioner Peterson left the office for the day.

Chairman Reinhardt left the office to get some prices on a dishwasher to replace the one at the Detention Center. He reported that Markles had an enamel faced Whirlpool at \$499, and Town & Country had a stainless steel faced Whirlpool dishwasher at \$475.


Chairman Reinhardt left the office for the day.

Gary Martin stopped in and informed Commissioner Peterson that the West Tampico Road needs to be mowed and bladed. He said the last time they worked on that road they did not finish it to his house and he was wondering why they did not finish the road all the way.

Commissioner Peterson said he would let Todd Young, Valley County Road Supervisor, know of Mr. Martin's concerns and Mr. Martin left the office.

A memo went out to the Department Heads to distribute to their employees advertising in-house for a homemaker at the Council on Aging.

Bob Steele, Maintenance Supervisor, visited with the Commissioners about the current maintenance projects. The generator cement pad was discussed and plans made to get it poured. The group reviewed the quote to replace the windows in the Community Room and the Clerk & Recorder's Office at an estimated cost of \$16,971.

The Commissioners said they would discuss this project further.

Mr. Steele said the new air conditioner motor that was put in last week was faulty and did not work and Dale's Plumbing and Heating ordered another one. There is still one motor working, but it does take two motors to run the system efficiently. Discussion followed.

Chairman Reinhardt said he had looked at the cooler at the Council on Aging and wondered about taking out the racks and have them sand blasted to remove the rust then painted with a special paint.

Mr. Steele said he thought the COA was looking into buying new racks to replace the old ones. Discussion followed.

Mr. Steele left the office.

Glen Meier, Valley County Sheriff, dropped off a contract from Phillips County for holding inmates in the Valley County Detention facility.

The Commissioners left the office from 1:00 to 4:00 p.m. to go to the Community Room to complete the FY 2015-146 budgets.

Chairman Reinhardt left the office for the day.

Fair Commission members Jerry Arnold and Adam Powell joined the meeting.

Mr. Arnold updated the Commissioners on what they believed to be the attendance and ticket sales for the Fair this past week. He said he and Mr. Powell had it figured that Saturday was the Ranch Rodeo and there was \$1,610 collected for tickets; Sunday night rodeo was \$6,670 for tickets; Monday night \$6,350

of tickets; and Tuesday night Demolition Derby was \$7,900 in ticket sales. Mr. Arnold said there was rodeo arena sponsor board fees collected this year of \$13,410, which was up about \$5,000 from past years. He said Dodge gives the Fair \$1,610 sponsorship each year and other sponsors donated \$2,445. There was \$4,198 collected for pre-sale tickets for all three of the night show events. The Beer Garden took in an estimated \$500 Saturday night, \$8,000 Sunday night and \$5,100 Monday night. The Fair Commission gets half of the beer garden's net profit. Discussion followed.

Mr. Arnold said the Carnival was very poorly attended. The all day tickets sold were only \$2,995 and the carnival owner said he only took in \$7,995 total for ticket sales. Discussion followed.

Mr. Arnold said the Fair Commission Board would like the pre-sale tickets broken out to see what was attended with those tickets.

Mr. Arnold said there is another carnival out of Arizona, Sun Valley Rides, that the Fair Commission would like to get next year at a cost of \$45,000, in comparison to the \$15,000 they are now paying for the current carnival. This carnival shares the profit with Valley County and the cost goes down. Discussion followed.


Mr. Arnold said the Fair Commission gets 12.5% from all the food booths, and that money should start coming in within the next couple of months.

Mr. Lighthizer left the office.



A motion was made by Commissioner Peterson authorizing the Chairman to execute a Notice of Employment for Lynn Miller as a permanent, part-time Nurse for the Health Department beginning August 24, 2015, at \$25.00 per hour. The motion was seconded by Chairman Reinhardt and it passed.

Commissioner Peterson said this part-time nurse position is set at 10 hours per week.

The next item on the agenda was the Zuercher Suite, a law enforcement computer program at an estimated cost of \$149,236.

The software product is Zuercher Suite, and the total price for hardware, software, installation and first year maintenance is \$149,236. The Commissioners are requesting E911 pay \$30,000, leaving a County total of \$119,236 for this new program. The purpose of this purchase is to replaced failing hardware and software of the current law enforcement system and the Zuercher system will also add tactical and intelligence capabilities not included in the current system Valley County is using. The City of Glasgow will have to consider purchasing this software for their offices too.

Chairman Reinhardt said that there has been some changes in the ownership of the company that we have been dealing with on this computer program, and the cost may go down. Sherri Turner, Sheriff's Administrative Assistant, is working with the company to possibly get a lower price. Discussion followed.

A motion was made by Commissioner Peterson to purchase Zuercher Suite, and all the accessories for a cost of no more than \$120,000 to Valley County, which will be paid out of Local Option Tax funds. The motion was seconded by Chairman Reinhardt and the motion carried.

The next item on the agenda was to consider the bids for Long Run's surplus equipment advertised in the paper; a garage Door, a 1980 International semi Model F4370 with a water tank and supplies on it and a 1990 K2500 pickup.

Chairman Reinhardt said that there were two bids submitted. A bid of \$1,287.50 from Dan Carney for the 1990 K2500 pickup; and a bid of \$2,750 from Fossum Ready Mix for the 1980 International Model F4370 - semi tractor/trailer with a 3,000 gallon water tank, and Fossum also bid \$350 for the 1990 pickup.

Chris Knodel, Long Run Fire Chief, had sent a note stating that Long Run would like to accept the two highest bids.

Commissioner Peterson made the motion to accept the bid from Dan Carney of \$1,287.50 for the 1990 Chevrolet Pickup, and a bid from Fossum Ready Mix of \$2,750 for the 1980 International Model F4370 - semi tractor/trailer with a 3,000 gallon water tank. Commissioner Peterson left the office for the day.







Second, would the Commissioners want Mr. Murnion to pursue the option to provide criminal prosecution services to the City of Glasgow.



Glen Meier, Valley County Sheriff, visited with Commissioner Tweten about the Fair Commission and some past events and history when Sheriff Meier was on the Fair Commission Board.

Mike Bain, Valley County Computer Technician, joined the meeting to give the Commissioners a report on the projects he completed in August.

The group discussed the proposed Zuercher computer program for law enforcement and some changes that will come about. The Commissioners asked if the City of Glasgow would have to also subscribe and pay to get on this program and Mr. Bain pointed out that yes, they would have to be on the same program for their documentation and investigation purposes. Discussion followed.

Mr. Bain left the office.

Todd Young, Valley County Road Supervisor, stopped in and visited with the Commissioners about the current Road Department activities.


