June 10, 2025

Present: Gary Howey, Paul Jensen and Valeria Schmauch

A. Welcome: All members were present.

B. Minutes of Prior Meeting:

The minutes of the previous (September 10, 2024) meeting were read by the board member. Paul Jensen moved to accept the minutes of the previous meeting, September 10, 2024 as written. Gary Howey seconded, and motion carried.

C. Old Business:

1. Application/Equipment/Applicator:

- a.) Equipment condition: We went through the recertification and calibration process. Everything is accurate and up to date.
- b.) Inventory of spray: We received fifty (50) gallons of spray and have thirty-five (35) gallons from prior year.
- c.) Applicator: Joe Stuber is our new applicator. He attended the calibration meeting. He is registered with Valley County. His wage is fifteen dollars (\$15.00) per hour. Paul Jensen has renewed his applicator's license and he will oversee Joe Stuber.

2. Record-Keeping/Finances:

- a.) We received financial reports from the Valley County Clerk. These include:
Detail Ledger Query: 1. For the Accounting Periods: 7/24 to 5/25 (5 pages); 2. Exp. Budget vs. Actual – Comparison Prior Years Report For the Accounting Period 5/25; 3.) Expenditure Budget vs. Actual Query For the Accounting Period: 5/25; and 4.) Expenditure Budget vs. Actual Query For the Accounting Period: 4/24. These documents accompany these minutes.
- b.) Using the 5/25 ledger page, we determined that we spent approximately eight thousand dollars (\$8,00.00) for spray, fuel and wages last season.

- c.) Paul Jensen renewed his applicator's license to oversee the employee who does the spraying. Paul will request reimbursement for his license expenditure.

 - b. Report from Valley County Treasurer:
Using the 7/24 to 5/25 ledger, the current available funds are fifty- three thousand seven hundred-twelve dollars and fifteen cents (\$53,712.15).

 - a. Purchase of spray for the 2025 season:
We received fifty (50) gallons of spray from Van Diest.
 - b. Sprayer calibration: Our sprayer stays in calibration throughout the season.

 - 1.) Bill from Ezzie's Wholesale Inc. has been received for gasoline for the sprayer and pick-up at a cost of \$107.64.
 - 2.) Fifty (50) gallons of spray has been purchased from Van Diest at a cost of two thousand, one hundred- sixty dollars (\$2,160.00).
 - b.) Financial Report from Valley County Treasurer – See previous listing in Old Business, 2. Record-Keeping/ Finances, a (C,2,a.)
